Citizen M Times Square Hotel – New York, NY

GMS provided limited façade consulting services for this new 20-story hotel located in Times Square.

Riu Hotel, Times Square – New York, NY

GMS provided façade consulting for this new mixed-use hotel and residential complex, with some retail, located on Eighth Avenue at 46th Street in Manhattan's Theatre District. The complex will consist of a nominal twenty eight (28) story tower with condominium units in portions of the lower 6 floors, hotel occupancy above the 6th floor and retail at the ground floor.
